

USB-C is fast becoming the universal charging standard and supporting more devices -

- The latest USB PD 3.1 spec extends the maximum power over USB-C to 240W from 100W, supporting more devices such as gaming notebooks, household appliances, e-bikes, and other higher powered devices
- EU's Common Charger Directive requires that all new devices sold in the EU must support USB-C charging from Dec, 2024 (laptops in April, 2026).


